- (1) 期數中每一個住宅單位的擁有人購買住客停車位及住客電單車停車位總數不得多於3個。
A purchaser of each residential unit shall only purchase not more than three in number of the total of the Residential Parking Spaces and Residential Motor Cycle Parking Spaces in the Phase.

Terms of Payment of the Residential Car Parking Spaces of the Phase
 - (1) 買方簽署臨時買賣合約時需繳付車位售價之 5% 作為臨時訂金。買方須於簽署臨時合約後5個工作日內簽署正式買賣合約(「正式合約」)。
5% of the transaction price as the preliminary deposit shall be paid by the Purchaser(s) upon signing of Preliminary Agreement for Sale and Purchase ("PASP"). The formal agreement for sale & purchase ("ASP") shall be signed by the Purchaser within 5 working days after signing of the PASP.
