**Part (I) : Abstract**

The sale of the specified residential properties will be divided into 3 groups (namely Group A1, Group A and Group B). The persons or companies interested in purchasing any of the specified residential properties are referred to below as “the registrant(s)”. Individual or company registrants (whether in his/her own name or in joint names with any other parties) can only participate in any **ONE** group. Duplicated registration among different Groups will not be accepted and his/her/their registration in later group(s) will lapse automatically.

**Part (II) : Registration**

**第(II)部分：登記**

1. The registrant(s) must submit the following **personally (for new registrant) or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor (for registrant who has previously registered under the “Information on Sales Arrangements No.1” or “Information on Sales Arrangements No.3” of the Phase of the Development)** to the Sales Office at or before 4 p.m. on the day before the First Date of the Sale (“the Deadline of Submission”):-

More than the allowed Registration of Intent (whether in his/her own name or in joint names with other parties) submitted from the same registrant will not be accepted. - i) Balloting of Group A1 will take place on 23 March 2018. The ballot results, including “registration number”, “ballot result sequence” and “the check-in timeslot for Group A1 registrants” shall be posted at the Sales Office at or before 8 p.m. on 23 March 2018. The registrant(s) will not be separately notified of the ballot results.

The Group A1 registrant(s) whose identity(ies) has/have been verified by the Vendor shall be eligible to select the specified residential properties which are still available at the time of selection in the order of priority in respect of the relevant Registration of Intent according to the ballot result sequence. The Group A1 registrant(s) who arrive at the Additional Designated Venue at any time later than “the check-in timeslot for Group A1 registrants” assigned in the ballot results shall not be eligible to select the specified residential properties according to the ballot results.

The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and Additional Designated Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time of the Group A1 Unit Selection. Any changes to the time of the Group A1 Unit Selection will be announced at the Sales Office. Registrants will not be notified separately of such changes.
