MALIBU 住客停車位發售事宜

MALIBU - Sale of Residential Parking Spaces

The Residential Parking Spaces of MALIBU ("the Parking Spaces") will be relaunched for sale at 11 a.m., on 2 October, 2022. Please refer to the (1) Price List No.5 for Parking Space (including 32 launched Parking Spaces (as at 21 September, 2022)) and (2) Floor plans of Residential Car Parking Space in MALIBU on the Vendor's website designated for MALIBU (www.malibu.com.hk) for details.

The 32 launched Residential Parking Spaces of MALIBU (as at 21 September, 2022) would not be available for sale from 22 September, 2022 (Today) until relaunch at 11 a.m. 2 October, 2022.

The above sales launch is only applicable to Owners of residential unit(s) of LOHAS Park Phase I, Phase IIA, Phase IIB, Phase IIC, Phase IIIA, Phase IVA, Phase IVB, Phase VA, Phase VI, Phase VIIA, Phase VIIB, Phase VIII, Phase IXA, Phase IXB or Phase IXC ("residential unit of LOHAS Park") who have completed the signing of an Assignment on or before 22 September, 2022; and who is and will be the registered owner of a residential unit of LOHAS Park at the time of purchasing and at the time of completing the sale and purchase of the Parking Space.

Card or passport of its director(s) and (ii) proof of residential unit ownership and select the Parking Space(s) which are still available at the time of selection on first-come-first-served basis (only applicable to Purchasers who purchased a residential unit of LOHAS Park who have completed signing of Assignments). In case of any dispute, the Vendor reserves its absolute right to allocate any of the Parking Space(s) to any interested parties by any method. The preliminary deposit shall

In case of any dispute, the Vendor reserves its absolute right to allocate any of the Parking Space(s) to any party interested in purchasing the Parking Space(s) by any method. The Vendor reserves the right to change the above sales arrangements or the Price List(s) by announcing the revised sales arrangements on MALIBU's designated website.
